# PHYSICAL THERAPY COMMON TREATMENTS

**CANINE PHYSICAL THERAPY** incorporates a carefully selected combination of rehab interventions that are customized to each patient's specific needs. This tailored prescription will utilize a selection of the following treatments.

## **MANUAL THERAPY:**

GOAL: Reduce pain and inflammation

- Joint mobilizations
  - Maitland mobilizations
  - Natural apophyseal glides (NAG)
  - Sustained natural apophyseal glides (SNAG)
  - Mobilizations with movement (MWM)
- Traction
- Soft tissue techniques
  - Soft tissue mobilizations
  - Myofascial release
  - Trigger point release
  - Cross friction massage
  - Proprioceptive neuromuscular facilitation (PNF)

#### THERAPEUTIC EXERCISE:

GOAL: Regain range of motion and strength

- Strengthening
- Flexibility
- Endurance
- Balance and Proprioception
- Return to work exercise
- Sport regimens

#### **GAIT TRAINING:**

GOAL: Improve mobility and coordination

- Trunk and limb motor control
- Neurofacilitation techniques
- Functional strength exercises
- Balance and proprioception on varied terrains
- Mechanics retraining, including speed, endurance, and obstacle navigation
- Prosthetics, orthotics, and wheelchairs

### **NEUROMUSCULAR THERAPY:**

GOAL: Improve balance and proprioception

- Neural mobilizations
- Faciliatory techniques for low tone
- Inhibitory techniques for high tone
- Neuro-developmental sequence retraining
- Postural management

#### THERAPUTIC MODALITIES:

GOAL: Reduce pain and inflammation

- Laser therapy
- Transcutaneous electrical nerve stimulation (TENS)
- Neuromuscular electrical nerve stimulation (NMES)

#### **VET FAQ:**

#### As a veterinarian, what is required of me prior to referring to animal PT?

The State of Nebraska requires veterinarians provide a letter of referral for PT. This letter must include a medical diagnosis and evaluation documentation. Veterinary assessment must have occurred in the 90 days immediately preceding the PT evaluation.

#### What health care services is an animal physical therapist allowed to perform?

Health care therapy provided by an animal PT is bound by the Nebraska Physical Therapy Scope of Practice. All animal PT treatment must be consistent with the licensed PT's education and training.

As a veterinarian, if I refer my patients to an animal PT, will I be held responsible for services rendered?

No. Per the Nebraska Legislature, Nebraska Revised Statute 38-3333, "A licensed veterinarian who prepares a letter of referral for health care therapy by a licensed animal therapist shall not be liable for damages caused to the animal as a result of the health care therapy performed by the licensed animal therapist."
